# HILTON ORGANISATION Child Sponsorship Scheme

The Hilton Organisation, known as The Fiji Crippled Children's Society – Suva Branch, is a non – profit organisation that caters to the needs of children and young adults in Fiji. The organisation is a pioneering project by Mr. Frank Hilton, and was set up in 1963.

Hilton Organisation currently caters to over 160 children and young adults, with disabilities and their families from Fiji and neighboring Islands in the region through the Hilton Special School, Hilton Early Intervention Centre, and Hilton Hostel.

Over 90% of the students who attend programmes at the Hilton organisations come from low income families.

## **Child Sponsorship Scheme**

All children sponsored are participating in programmes at the Hilton Organisation namely Hilton Special School, Early Intervention Centre and Hilton Hostel. The primary aim of the sponsorship programme is to subsidise the cost of education and related services for children from low income families.

Once a child is enrolled into the scheme with a sponsor, the child receives support based on the needs that are identified by the Head Teacher and Sponsorship Coordinator who are in charge of monitoring the child's progress.



### **Benefits To Child & Family**

- Subsidised cost of education
- Subsidised cost of transportation
- Nutrition/nutritional supplements
- Clothing/health and hygiene requirements
- Medication
- Education and related services

The level of assistance provided to each child varies depending on their financial situation.

# **How Can I Help?**

One or more individuals could sponsor a child or group of children. Payment can be made in cash, cheque or direct bank remittance. Payments can be made on a bi-annual or annual basis. Overseas contributions can be remitted through any of the above methods. The sponsor will be kept informed on progress through a quarterly Newsletter.

The sponsorship sought per child per annum is \$500. This is an average approximation of the level of financial support needed to subsidise the cost of providing services to each subsidised child.
